This instrument may at any time be amended or repealed only by amendment or repeal of the Amended Covenants, in the manner described in the Amended Covenants. The duration of the covenants, conditions and restrictions made applicable to the property annexed by this instrument to the Business Park shall commence on the date of recording hereof, and unless otherwise terminated shall continue, renew and terminate coincidentally
