SUNRIVER DECLARATION SUBJECTING CERTAIN  
AREAS TO THE PLAN OF SUNRIVER

By instrument dated June 20, 1968 and recorded on June 20, 1968 in Volume 159 of the Records of Deeds of Deschutes County, Oregon at page 198, SUNRIVER PROPERTIES, INC., an Oregon corporation (the "Developer"), has established the Plan of Sunriver.

The Plan of Sunriver provides that land may be subjected to the Plan of Sunriver by the filing of a declaration by Developer in the records of deeds of Deschutes County, Oregon, subjecting such land to the Plan of Sunriver. The Plan further provides for the classification of land so subjected to the Plan of Sunriver. Such land classifications include "private ways."

Developer now wishes to subject certain land to the Plan of Sunriver and to provide for the classification thereof.

NOW, THEREFORE, Developer does hereby declare and provide, pursuant to Sections 1.13 and 2.1 of the Plan of Sunriver, that the property described on Exhibit A attached hereto shall be subject to the Plan of Sunriver and shall constitute "private ways" within the meaning of Section 4.1 of the Plan of Sunriver, reserving, however, unto Sunriver

Properties, Inc., its successors, assigns, lessees, licensees and guests, a nonexclusive, perpetual easement for walking or traveling thereon.


