## SECOND AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS FOR BUSINESS PARK I

By instrument entitled "Declaration of Protective

Covenants for Business Park I," dated July 26, 1974 and recorded
on July 26, 1974 in Book 209 of the Deed Records of Deschutes

County, Oregon, at page 10, SUNRIVER PROPERTIES, INC., an Oregon
corporation (hereinafter "Grantor") established certain conditions,
covenants, restrictions and agreements governing the property
situated in Deschutes County, Oregon, more particularly described
in such declaration and referred to therein as "the Business
Park." The declaration has been amended by instrument dated
September 29, 1975 and recorded September 30, 1975 in Book
223 of the Deed Records of Deschutes County, Oregon, at page
461.

Pursuant to Section 8.02 of such declaration, Grantor, who is the owner of more than 65 percent of the land area of Sites within the Business Park, now wishes to amend such declaration for the purpose of establishing a procedure for waiver of setback lines and land coverage requirements.

NOW, THEREFORE, Grantor does declare and provide that the above-described declaration shall be amended as follows:

1. The following sentence shall be added at the end of Section 5.01 dealing with setback requirements:

> "The setback requirements set forth herein or on the plat of the Business Park may be waived or amended by Grantor as to any Site

2. The following sentence shall be added at the end of Section 5.02 relating to land coverage:

> "The land coverage requirements of this section may be waived or amended by Grantor as to any Site by a statement thereof contained in any deed, conveyance or other instrument recorded in the Deed Records of Deschutes County, Oregon."
