W I T N E S S E T H:

On July 31, 1969, Declarant executed and recorded a declaration submitting Sunriver Lodge to the provisions of the Unit Ownership Act of Oregon. That declaration was recorded in Volume 165, at page 821, Deed Records of Deschutes County, Oregon. Contemporaneously therewith, Declarant recorded a Site Plan and Floor Plans of Sunriver Lodge in Volume 165, beginning page 852, Deed Records of Deschutes County, Oregon.

Declarant has now discovered that pages 15 and 16 of said plans, appearing on pages 268 and 269 of Volume 165, Deed Records, Deschutes County, Oregon, were in error and did not accurately depict Sunriver Lodge as it then existed.

NOW, THEREFORE, Declarant submits herewith an Amended Site Plan and Floor Plans of Sunriver Lodge, which amended plans correct the errors in pages 15 and 16 of the original plans.


