The following subparagraph (k) will be added to paragraph 8 of the Declaration of Sunriver Lodge:

(k) Time Share Plan. No unit shall be used in connection with a time share plan as that term is defined in the Administrative Rules of the Oregon Real Estate Commissioner or in the statutes of the state of Oregon. The creation of a time share plan involving any portion of the Project is prohibited.
