

AMENDED DECLARATIONS, COVENANTS, CONDITIONS AND RESTRICTIONS

88-24735 FOR

TALL PINES FIFTH ADDITION SUBDIVISION

DESCHUTES COUNTY, OREGON

In accordance with the declarations, covenants, conditions and restrictions the undersigned being more than fifty-one (51%) percent of the members entitled to cast more than fifty-one (51%) percent of the votes of membership in the Association, hereby amend the declarations, covenants, conditions and restrictions for Tall Pines Fifth Addition, Deschutes County, Oregon recorded in Volume 227, Page 831 of the Deschutes County Deed Records. The Amendment in Volume 340, Page 575 is superceded and replaced by the Amendment, and shall be of no further force or effect.
