DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR TAMARACK PARK EAST PHASE V

By instrument dated May 6, 1987, and recorded May 13, 1987, in Volume 145, Page 1795, Official Records of Deschutes County, Oregon, PACIFIC NORTHWEST DEVELOPMENT CORPORATION, an Oregon Corporation, established the Declaration of Covenants, Conditions and Restrictions for Tamarack Park East.

NOW, THEREFORE, Declarant does hereby declare and provide as follows:

SECTION 1. DEFINITIONS

- 1.1 INCORPORATION BY REFERENCE: Each of the terms defined in Section 1 of the Declaration for Tamarack Park East shall have the meanings set forth in such Section 1.
- 1.2 The "property" shall mean Tamarack Park East, Phase V, as described in Exhibit "A" attached hereto.
- 1.3 Declaration of Covenants, Conditions and Restrictions for Tamarack Park East shall mean that certain document entitled "Declaration of Covenants, Conditions and Restrictions for Tamarack Park East" dated May 16, 1987, recorded May 13, 1987, in Volume 145, Page 179, Official Records of Deschutes County, Oregon.
- 1.4 "Tamarack Park East, Phase V", shall mean the area described on Exhibit "A" attached hereto.
- SECTION 2. SUBJECTION OF TAMARACK PARK EAST PHASE V TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR TAMARACK PARK EAST
- 2.1 ANNEXATION: Declarant hereby declares that Tamarack Park East, Phase V, shall be part of that certain residential

The property shall be held, conveyed, hypothecated, encumbered, used, occupied and improved only in accordance with the provisions made in this instrument and the Declaration of Covenants, Conditions and Restrictions for Tamarack Park East.

SECTION 3. MISCELLANEOUS
