AMENDMENT TO BYLAWS OF TENNIS VILLAGE TOWNHOUSES ASSOCIATION, INC.

SECTION 19 ATTORNEY'S FEES, INTEREST AND LATE FEE

Each unit owner promises and agrees to pay the Association's reasonable attorney's fees and collection costs with respect to collection of delinquent dues, assessments and other sums owing to the Association by a unit owner. If any suit or action is filed, the amount of such reasonable attorney's fees shall be fixed by the court or courts in which the suit or action, including any appeal therein, is tried, heard or decided, plus for attorney's fees and costs incurred seeking relief from stay in bankruptcy court. Such sums shall include an amount estimated by the Court as reasonable costs and fees to be incurred by the prevailing party in collecting any monetary judgment or award or otherwise enforcing each order, judgment or decree entered in such suit, action or other proceedings.

Interest at the rate of 18% per annum shall be charged on all past due sums if those sums owing the Association by a unit owner are not paid within 15 days of mailing of the bill setting forth the sums owing by to the owner by the Association. Further, a one-time late fee charge of \$25.00 will be charged to each unit owner for each separate charge or fee owing to the Association by the owner which is not paid within 15 days of mailing of the notice of the charge or fee to the owner by the Association.
