The value of said residence shall not be less than Twenty Five Thousand and No/100's (\$25,000) Dollars, including attached garages and porches. Mobile homes shall be an exception as noted in paragraph (g) below.

g. Mobile homes no smaller than Twenty-four (24) feet in width, to be used as permanent residences, will be allowed on any parcel. All mobile homes and outbuildings used in connection with such mobile homes shall be constructed and shall be kept painted to remain aesthetically compatible with homes in the area. All mobile homes placed upon the property shall have a pitched, shingled roof with eaves and a foundation or skirt of matching metal. No more than one mobile home unit or house may be located on each tract.

## STORAGE AND ACCESSORY REQUIREMENTS.

Fach mobile home shall be provided with an accessory building and shall enclose a minimum of 80 (8 X 10) square feet for accessory storage. Note: Storage building will be constructed within 60 days of placement of mobile home.
