THIRD AMENDMENT TO DECLARATIONS, RESTRICTIONS, PROTECTIVE COVENANTS AND CONDITIONS FOR VANDEVERT RANCH

This Third Amendment to the Declarations, Restrictions, Protective Covenants and Conditions for Vandevert Ranch (the "Amendment") is made this 20th day of November, 1996, by the VANDEVERT RANCH ASSOCIATION, INC., an Oregon non-profit corporation (the "Association"), is as follows:

RECITALS

A. On or about August 31, 1992, James A. Gardner and Carol W. Gardner, recorded that certain Declarations, Restrictions, Protective Covenants and Conditions for Vandevert Ranch in Book 275, Page 282 in the official records of the County Recorder of Deschutes County, Oregon. On or about December 22, 1994, the Association caused that certain First Amendment to Declarations, Restrictions, Protective Covenants and Conditions for Vandevert Ranch to be recorded in Book 361, Page 1830 in the official records of the County Recorder of Deschutes County, Oregon. Subsequent amendments made by the Association were recorded in the official records of the County Recorder of Deschutes County, Oregon as follows:

Second Amendment

March 5, 1996

Book 401, Page 2793

The original Declaration and the First and Second Amendments to the Declarations, Restrictions, Protective Covenants and Conditions for Vandevert Ranch are hereinafter collectively referred to as the "Declaration".

- B. The Declaration encumbers that certain project known as Vandevert Ranch located in Deschutes County, Oregon, and more particularly described in Exhibit A attached hereto and made a part hereof.
- C. The Association desires to make certain amendments to the Declaration regarding aerial and antenna devices at Vandevert Ranch.
- D. Article XII, Section 2 of the Declaration provides that the Declaration may be amended upon the affirmative vote or written consent, or any combination thereof, of at least two-thirds (2/3) of the members and the consent of the Declarant, so long as Declarant has an unexpired option to subject property to this Declaration.
- E. By written consent, two-thirds (2/3) of the members has given approval to the amendments set forth herein and the Declarant has consented thereto.
- F. By this Amendment and pursuant to the power reserved to the Association to amend the Declaration, as provided in Article XII, Section 2 thereof, the Association desires to amend the Declaration as hereinafter set forth.

AMENDMENT

1. Article III, Section 1 of the Declaration is hereby amended by deleting the entire paragraph and by substituting the following Section 1 therefor:

"Section 1. AERIALS AND ANTENNAS. No radio or television or other aerial, antenna, dish, tower, or other transmitting or receiving structure, or support thereof, shall be erected, installed, placed or maintained on a Lot except as permitted by the Board of Directors of the Association."

2. Except as modified by this Amendment, the Declaration and each of its provisions shall remain in full force and effect without change.
