Exceptions to this restriction shall be developer or builder owned properties. Individual property owners may request an exception from the Architectural Control Committee for personal emergency purposes only, with approval given at the discretion of the Architectural Control Committee.

All other provisions of said Declaration shall remain unchanged.
