"9. No masonry block construction shall be used except for chimneys, flues or other ornamental work. All foundations, footings, basement walls and pier posts shall be poured reinforced concrete of a mix as approved by the FHA Specifications for such purposes, except pier posts which require no reinforcings.

In all other respects the Building and Use Restrictions as heretofore recorded shall remain in full force and effect.
