Committee.

ARTICLE 2. PARAGRAPH 17

As written: Utilities, and all connection thereto, shall be constructed and maintained

below ground, and no wire, pipe, conduit, tank, or facility shall be visible above the surface of the earth except where connecting to the dwelling or outbuilding to the extent necessary to make such connections.

Amends to read: Utilities, and all connections thereto, shall be constructed and

maintained below ground, and no wire, pipe, conduit, tank, or facility shall be visible above the surface of the earth except where connecting to the dwelling or outbuilding to the extent necessary to make such connection. In cases of the installation of Cellular and PCS Utility Equipment, all equipment, including antennas, shall be concealed with a building type structure approved by the Architectural Review Committee.

ARTICLE 2. PARAGRAPH 18

As written: No commercial enterprise shall be conducted upon the premises, but

this restriction shall not apply to the occasional consultation with an

owner.

Amends to read: No commercial enterprise shall be conducted upon the premises, but

this restriction shall not apply to the occasional consultation with an owner or the operation of a wireless telephone facility (Cellular or PCS Utility Facilities). Any operator of wireless telephone facility operation within the Wild Horse Ridge subdivision will pay the association a "Good

Neighbor Fee" of \$5,000 and a monthly fee of \$350.
