Be it hereby resolved that the following amendment to the Declarations, Restrictions, Covenants and Conditions for Wild River, Deschutes County be made on the date first hereinabove written as hereafter set forth, to wit:

Annexation

Article _____ Section _____

Additional lands not included in the original Declaration may be annexed to and made a part of Wild River, or may become incorporated into the Association if all of the following conditions are met:

- a) Declarants to the proposed annexation must record current Declarations, Restrictions, Covenants and Conditions which are approved by a 2/3 majority of the members of the Association.
- b) Fee title to not less than 15% of the total land area must be conveyed to the Association as common area, said common areas to be approved by the Board of Directors.
- c) Declarants must sign and agree to abide by the Articles and By-laws of the Association.
- d) Annexation must be approved by a 2/3 (two-thirds) majority of all members, excepting however the votes of the developer, which shall be considered one vote when voting in favor of an annexation

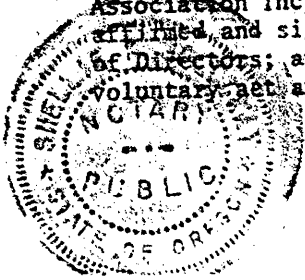
