- 1.2 The "Property" shall mean Windance Estates Phase II as described in Exhibit "A", attached hereto.
- 1.3 Declaration of Covenants, Conditions and Restrictions for Windance Estates shall mean that certain document entitled "Declaration of Covenants, Conditions and Restrictions for Windance Estates Phase I" dated November 19, 1992, and recorded November 19, 1992, in Volume 283, Page 0085, Official Records of Deschutes County, Oregon.
- 1.4 Windance Estates, Phase II shall mean the area described on Exhibit "A", attached hereto.
