WHEREAS, on the 11th day of September, 1993, at a special meeting of the Winston Ranch Property Owners Association, 75% or more of the total votes entitled to be cast approved the following amendments to the Declarations, Restrictions, Protective Covenants and Conditions for Winston Ranch recorded in Volume 282, at page 721, Deed Records, Deschutes County, Oregon; and

WHEREAS, the Secretary of the Association has attached her certificate to this amendment certifying that the Association approved by a vote amounting to 75% of the total votes entitled to be cast for this amendment; and

WHEREAS, the Board of Directors consisting of Linda Moskowitz, Joyce Lee, and Diane Wirth have joined in this amendment as evidenced by their signatures hereto;

NOW, THEREFORE, the Declarations, Restrictions, Protective Covenants and Conditions for Winston Ranch are hereby amended as follows:

- i. Article V, Restriction 17 The last sentence shall be deleted and the following to be added:
 - "(a) No domestic animals of any kind shall be raised or permitted on a unit other than a reasonable number of household pets which are not kept, bred or raised for commercial purposes and which are reasonably controlled so as not to be a nuisance to other units, persons or their livestock.
 - (b) Pets shall not be permitted to run loose off of Homeowners' property, except under effective leash or voice control.
 - (c) Ownership or possession within Winston Ranch of a victous dog is prohibited. A victous dog is defined as:
 - (1) Any dog which, when unprovoked, approaches any person in a vicious or terrorizing manner in an apparent attack anywhere other than on the owners or possessor's property.

Amendment - Page 1 -

- Any dog which has a known propensity, tendency or (2)disposition to attack without provocation to cause injury or otherwise endanger the safety of persons, other domestic animals or livestock.
- Any dog which bites, inflicts injury upon, (3) assaults or otherwise attacks a person, domestic animal or livestock without provocation on common, public or private property.
- Any dog which is kept or trained for the purpose (4) of dog fighting."
- Article V The following restriction has been added as follows and numbered accordingly:

All buildings shall have the exterior completed in "21. compliance with the appropriate regulations within twelve (12) months from the starting date of said project."
