## AMENDMENT TO COVENANTS, CONDITIONS AND RESTRICTIONS FOR WYNDEMERE, A PLANNED COMMUNITY DESCHUTES COUNTY, OREGON

The Owners of WYNDEMERE, A PLANNED COMMUNITY, do hereby adopt this amendment by a vote by written ballot in lieu of a meeting, in accordance with ORS 94.647. This Amendment amends the Covenants, Conditions and Restrictions for Wyndemere, a Planned Community, recorded on September 27, 1988 in Deschutes County Official Records at Book & Page: 171-384, Document no. 1988-21929, as amended by the Amendment of Covenants, Conditions and Restrictions for Wyndemere, a Planned Community recorded May 6, 1992 in Deschutes County Official Records at Book & Page: 264-1799 and Document no. 1992-14555.

1. Article III, Section 3.5, Subsection (C), <u>Increase of Annual Assessments</u>, is hereby deleted and replaced with the following language:

## (C) Increase of Annual Assessments:

The Annual Assessments for each succeeding fiscal year may be increased by the Board for the next year without a vote of the Members by an amount which shall not exceed 6% of the Annual Assessments for the fiscal year in which such budget is required to be prepared. Any increase in the Annual Assessments which exceed 6% of the preceding year's Annual Assessments shall be made only upon the affirmative vote or written consent of a Majority Owner. To the extent that the Association realizes a profit during any fiscal year, the Board shall allocate such profit among the existing Owners in equal proportions and apply such amount to satisfaction of each Owner's annual assessment. The surplus, if any, shall be deposited into the Wyndemere Association Capital Account (hereinafter defined) and used for the purposes and on the terms set forth in Section 3.5(D) below.

2. Except as hereinabove set forth, the Covenants, Conditions, and Restrictions of Wyndemere, A Planned Community recorded on September 27, 1988 in Deschutes County Official Records at Book & Page: 171-384, Document no. 1988-21929, as amended by the Amendment of Covenants, Conditions and Restrictions for Wyndemere, a Planned Community recorded May 6, 1992 in Deschutes County Official Records at Book & Page: 264-1799 and Document no. 1992-14555 shall remain in full force and effect.
